

Overview

Nationally renowned in pedal access for the treatment of peripheral artery disease, we perform minimally invasive endovascular procedures to treat patients with claudication, rest pain, and lower extremity threatened limb loss.

This facility is designed to help patients receive quality care outside of the traditional hospital setting. Patients will now have the flexibility, convenience, and control to schedule a variety of cost-effective procedures.

Using cutting-edge technology, our board-certified cardiovascular and thoracic surgeons and our highly skilled staff work together to perform the necessary tests to accurately diagnose and treat patients in a cost-effective manner.

Zero Contrast Pedal Approach

In the majority of cases, we perform the pedal approach. This approach allows access to the arterial system through the foot, as opposed to the groin. This lessens complications, shortens recovery time, and encourages early ambulation.

This is now the preferred treatment method for claudication, rest pain, and even threatened limb loss. Combining this approach with Intravascular Ultrasound (IVUS) and zero use of contrast (dye) maximizes the benefits of this approach and increases safety.

In addition to performing arterial intervention treatments, Dr. Zadeh and Dr. Levy also perform venous procedures such as:

- ClariVein
- VNUS Closure
- Sclerotherapy
- Varithena

These are for the treatment of varicose veins, leg ulcers, lower extremity edema, and saphenous vein reflux disease. These four procedures are done in the North Canton clinic, in an in-office setting.



By performing the pedal approach, we significantly reduce the risk of treating peripheral artery disease.

Treatment

Conditions we treat include:

Peripheral Arterial Disease, Abdominal Aortic Aneurysm, Chronic Venous Insufficiency, Deep Vein Thrombosis, Peripheral Aneurysm, Renal Vascular Conditions, Varicose Veins, and Vasculitis.

Procedures performed in our cath lab include:

Diagnostic Angiography, Peripheral Revascularization, Diagnostic Venography, Diagnostic Intravascular Ultrasound (IVUS)

Non-invasive testing:

Duplex ultrasounds, including the carotid, arm, and leg arteries as well as the abdominal aorta. Venous duplex ultrasound, including lower extremities.



Zero contrast peripheral interventions eliminate the need for contrast material and allow for safer procedures.
